The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any cremation arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, in some cases the remains may be made presentable by refrigeration and a skilled funeral professional on a case by case basis. Items not included in our price and any additional items such as urn selection, boat services, out of area shipment of remains, coroner fees, state fees, obituary notices and certified copied of the death certificates.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for in full or in part, by or on behalf of the decedent.

Itemized Selections

- **Provide Scattering of Cremated Remains in the Garden at Skyview Memorial Lawn.** **\$885.00**
 You **May Exchange** the above at the time of need for a **General Sea Scatter** or **Release to a Designated Person** in a travel urn. The designated person may select and pay for an urn at the time of need.
- **Cemetery Garden Endowment Care** **\$75.00**
- **Established Business Overhead** **\$320.00**
 Includes office rent, clerical, accounting, insurance, communications, advertising, and other related costs.
- **Transportation and Equipment Costs** **\$250.00**
 For transportation of the decedent to our holding facility within a 75 mile radius of our nearest office. Other areas outside of our service area, state or country will be charged an additional fee.
- **Creating and Obtaining Necessary State Documents and Death Certificates** **\$25.00**
 All staff are required to take state-mandated courses to complete these documents
- **Basic Cremation Container** **\$45.00***
 A special needs container for remains with height and weight (above 300lbs) that Exceed the capacity of the basic container will be charged an additional fee.
- **Refrigeration and Cremation** **\$320.00**
 Includes holding the remains in our nearest holding facility, properly Identifying the decedent and issuing a numerated identifying tag as part of the identification process.
- **Processing of Cremated Remains** **\$75.00***
 For final disposition and placement in a transport urn (sales tax not included)
- **Optional World Wide Travel Plan (Non Refundable)** **\$495.00**
 This plan extends your coverage throughout the United States and across the world. It guarantees no additional cremation charges regardless of where the death may occur. Our plan follows you while traveling or if you move residence outside our service area.

Direct Cremation Package-Local Coverage **\$1995.00**

Direct cremation is the disposition of the body by cremation, without the added cost of embalming and formal viewing. Our charges include: cremains scattering in a garden, endowment care, 24 hour emergency alert cards, the basic services of the cremation specialist and staff, transportation of the deceased with in out service areas (75 mile radius of Neptune society office), to our licensed holding and crematory facility, minimum preparation of the deceased, use of a proven identification system, procurement of a death certificate and necessary permits, assistance with filing for benefits through social security and veterans administration (if applicable), refrigeration until the cremation takes place, alternative container, the cremation process, processing and handling of cremated remains into a travel urn and scattering the cremated remains at sea or release the cremated remains to the family at one of our Neptune Society locations or scatter the cremated remains in a cemetery garden.

Direct Cremation Package with Travel Protection Program **\$2490.00**

With the addition of world wide coverage to the above local plan, we will extend your coverage beyond the 75 mile radius of a Neptune Society office to cover the United States and across the world. Cremation will take place locally, wherever the death may occur, the cremated remains are shipped back to California or wherever you stipulate. This package guarantees no additional cremation charges regardless of where death may occur. Our plan follows you while traveling or if you move residence outside of California.
